## The Surrey County Council Reigate Road (A25) Brockham/Betchworth (40mph Speed Limit) (Amendment) Order 202-

SURREY COUNTY COUNCIL in exercise of their powers under Section 84 of and Part IV to Schedule 9 to the Road Traffic Regulation Act 1984 ("the Act") and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act hereby make the following Order:-

- 1 THIS Order may be cited as "Reigate Road (A25) Brockham/Betchworth (40mph Speed Limit) (40mph Speed Limit) (Amendment) Order 202-" and shall come into operation on \*
- 2 (1) In this Order unless the context otherwise requires the following expressions shall have the same meanings hereby respectively assigned to them –

"enactment" means any enactment whether public general or local and includes any order bylaw rule regulation scheme or other instrument having effect by virtue of an enactment "motor vehicle" has the same meaning as in Section 136 of the Act "Principal Order" means The Surrey County Council Sevenoaks-Redhill-Guildford Road (A25) Dorking and Coles Lane (B2126) Ockley (Revocation of 50 mph Speed Limit and Imposition of 40 mph Speed Limit Order 2009

(2) Any reference in this Order to any enactment shall be construed as a reference to that enactment as amended applied consolidated reenacted by or as having effect by virtue of any subsequent enactment

- (3) Any reference in this Order to a numbered Article shall unless the context otherwise requires be construed as a reference to the Article bearing that number in this Order
- (4) Unless the context otherwise requires any expression used in this Order which is also used in the Principal Order shall have the same meaning as in that Principal Order
- 3 WITHOUT prejudice to the validity of anything done or to any liability incurred in respect of any act or omission before the coming into operation of this Order no person shall drive any motor vehicle at a speed exceeding 40 miles per hour on the lengths of roads specified and described in The Schedule to this Order
- 4 WITHOUT prejudice to the validity of anything done or to any liability incurred in respect of any act or omission before the coming into operation of this Order the Principal Order shall have effect as Article 2(b) and the Second Schedule has been omitted in its entirety
- 5 NO speed limit imposed by this Order applies to vehicles falling within Regulation 3(4) of the Road Traffic Exemptions (Special Forces) (Variation and Amendment) Regulations 2011 when used in accordance with Regulation 3(4) of those Regulations

that length of Sevenoaks-Redhill-Guildford Road (A25) known as "Reigate Road (A25) Brockham/Betchworth" which extends from a point 25 metres north -east of the north-eastern kerb-line of Castle Gardens north-eastwards then eastwards to a point

47.5m west of the intersection of the centre line of Tranquil Dale with the northern channel line Reigate Road, a distance of approximately 3,220 metres
