Surrey County Council propose to make the above named Order, under Section 84 of and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 "the Act" (as amended) and all other enabling powers, the effect of which will be to —

- (a) impose a 20mph speed limit in the lengths of roads specified in The Schedule to this Notice. The speed limit proposed by this Order shall not apply to vehicles used by special forces in accordance with the Road Traffic Exemptions (Special Forces) (Variation and Amendment) Regulations 2011;
- (b) revoke "The Surrey County Council Various Roads in Reigate (Temporary 20 mph Speed Limit) Order 2020" in its entirety.

- **(b)** High Street (A25)/West Street (A25) Reigate, from the junction with A217 Bell Street to a point 4m west of the junction with D3104 Park Lane;
- (c) Bancroft Road (A25) Reigate, its entire length;
- (d) Bell Street (A217) Reigate, from its junction with A25 Church Street to the southern property boundary of No. 109B Bell Street;
- **(e)** Access from Bell Street to Superstore (D131) Reigate, the entire length of highway maintainable at public expense, a distance of 60m;
