Various Roads in Shackleford
(20MPH and 30MPH Speed Limit)(Part-Revocation) Order 202-

Surrey County Council propose to make the above-named Order, under Section 84 of and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 (as amended) and of all other enabling powers, the effect of which will be to: - **1.** Impose a maximum speed limit of 20 miles per hour on the lengths of road specified and described in the First Schedule to this Notice. **2.** Impose a maximum speed limit of 30 miles per hour on the lengths of road specified and described in the Second Schedule to this Notice. **3.** “The Surrey County Council Various Roads in the Parishes of Pirbright, Puttenham, Shackleford, Shalford and West Clandon (30/40 MPH Speed Limits) Order 2002” shall be amended so shall have effect as though Parts (iii) and (viii) to the First Schedule (that restricts the maximum speed limit to 30MPH in lengths of C23 Lombard Street, C23 The Street and D93 The Street specified and described in the First Schedule to this Notice), and Parts (iii) and (vi) to the Second Schedule (that imposes a maximum speed limit of 40MPH in the lengths of C23 Grenville Road and D93 Puttenham Lane specified and described in the Second Schedule to this Notice) are revoked in entirety.

The speed limits proposed by this Order shall not apply to vehicles used by special forces in accordance with the Road Traffic Exemptions (Special Forces) (Variation and Amendment) Regulations 2011. FIRST SCHEDULE

- a)** That length of C23 Lombard Street, Shackleford that extends from its junction with D93 The Street, westwards for a distance of 290m to the western side of the access road for “Archfield”.
- b)** The entire length of D93 The Street, Shackleford.
- c)** The entire length of C23 The Street, Shackleford.

SECOND SCHEDULE

- a)** That length of C23 Lombard Street, Shackleford that extends from its junction with C23 Cuttmill Road, to a point 290m west of its junction with D93 The Street, at the western side of the access road for “Archfield”.
- b)** The entire length of C23 Cuttmill Lane, Shackleford.

c) That length of C23 Grenville Road that extends from a point 43m south-east of its junction with C23 The Street, to its junction with C25 Elstead Road.

d) That length of D93 Puttenham Lane, Shackleford that extends from its junction with D93 Hook Lane, to a point 208m north of the centreline of its junction with D93 Hook Lane.
