Proposed Traffic Calming Measures
in A281 The Street and A248 Kings Road, Shalford

Surrey County Council in exercise of their powers under Section 90(A) to (I) inclusive of the Highways Act 1980 propose to introduce a series of physical measures to improve safety and reduce vehicle speeds in A281 The Street and A248 Kings Road, Shalford, as follows: -

1. A281 The Street, Shalford –
 - (a) **full width flat-topped road table**, which will be centred at a point 8.9m north of the centre line of the access to the electricity sub-station between the junction Station Road and the junction with Tillingbourne Road;
 - (b) **full width flat-topped road table**, which will be centred at a point 18.1m north of the centre line of the junction of the access into Malthouse Court, GU4 8BJ;
 - (c) **two abreast speed cushions**, which will be centred at a point 29.8m north of the pedestrian access into St Mary's Church;
2. A281 Kings Road, Shalford –
 - (a) **full width flat topped road table**, which will be situated on the existing zebra crossing outside No.7 Kings Road, centred at a point 12m west of Chinthurst Lane. The proposed road table will have a gradient of 1:20;
 - (b) **full width flat topped road table**, which will be centred at a point 55m north-west of the centre line of the junction with Station Road. The proposed road table will have a gradient of 1:20;
 - (c) **two abreast speed cushions**, which will be centred at a point 13.6m north-west of the junction of the centre line of the junction with the middle arm of X248 Christmas Hill;
 - (d) **two abreast speed cushions**, which will be centred at a point 15.1m north-west of the centre line of the junction with the easternmost arm of X248 Christmas Hill.

The full width road tables will be 10.5m in length, with a 7.5m flat top and the speed cushions will be 3.5m in length per cushion.

If you wish to object to, or make any other representation regarding the proposed measures, you must send the grounds for your objection or representations (including any in support) by **31 January 2025** –
- (i) in writing to Traffic Regulation Orders Team, Surrey County Council, Hazel House, Merrow Lane, Guildford, Surrey, GU4 7BQ;
 - (ii) or by using the online form via the website quoted above.
