Surrey County Council
(Various Roads in Sunbury) (20mph Speed Limit) Order 202-

Surrey County Council propose to make the above named Order, under Section 84 of the Road Traffic Regulation Act 1984 “the Act” (as amended) and all other enabling powers, the effect of which will be to impose a 20mph speed limit in the lengths of roads specified in the Schedule to this Notice.

(N.B. Rooksmead Road, Sunmead Road and part of Stratton Road are already signed as being subject to a 20mph zone. This proposal will formalise the 20mph speed limit and replace the existing 20mph zone signs).

The speed limits proposed by this Order shall not apply to vehicles used by special forces in accordance with the Road Traffic Exemptions (Special Forces) (Variation and Amendment) Regulations 2011. A copy of the proposed Order, a plan showing the lengths of roads to which the Order relates, and a Statement of the Council’s reasons for proposing to make the Order and a Statement of the Council’s guidelines on the acceptance of objections to Traffic Regulation Orders may be viewed:
