

**Notice**  
**The Surrey County Council**  
**Trodds Lane (D4009) Guildford**  
**(30Mph and 40 Mph Speed Limit) Order 202-**

Surrey County Council propose to make the above-named Order under Section 84 of the Road Traffic Regulation Act 1984 (as amended) and of all other enabling powers the effect of which will be to

- (a) extend the 30 miles per hour maximum speed limit in that length of Trodds Lane (D4009) Guildford as extends from a point in line with Street Lighting Column N15 to the existing 30mph/National Speed Limit Terminal point 25 metres southeast of its junction with the centre line of the access to No.37 Trodds Lane also known as “Newlands Cottage”; and
- (b) impose a 40 miles per hour maximum speed limit in that length of Trodds Lane (D4009) Guildford as extends from a point 25 metres southeast of its junction with the centre line of the access to No.37 Trodds Lane also known as “Newlands Cottage” to the existing 40mph terminal point 35 metres northwest of its junction with (A25) Shere Road.

The speed limits proposed by the above-mentioned Order shall not apply to vehicles used by special forces in accordance with the Road Traffic Exemptions (Special Forces) (Variation and Amendment) Regulations 2011.
