Proposed Traffic Calming Measures
in Upper Hale Road (A3016) Farnham

SURREY COUNTY COUNCIL in exercise of their power under Section 90(A) to (I) inclusive of the Highways Act 1980 propose to introduce a series of traffic calming features in Upper Hale Road (A3016) Farnham, the locations of which are specified and described in the Schedule to this Notice.

The proposed speed tables parts (a), and (d) of the Schedule to this Notice will extend across the full width of the carriageway and be 75 millimetres in height, 10 metres overall in length with a 7 metre flat top and 1.5 metre ramps at a 1:20 gradient

The proposed speed table in part (b) of the Schedule to this Notice will extend across the full width of the carriageway (which will be narrowed to 5.5 metres) and be 75 millimetres in height, 10 metres over all in length with a 7 metre flat top and 1.5 metre ramps at a 1:20 gradient

The proposed speed table in part (c) of the Schedule to this Notice will measure 75 millimetres in height, 10 metres overall in length with a 7 metre flat top and tapered edges, it will be 6.34 metres wide with 1.5 metre main ramps at a gradient of 1:20

Upper Hale Road (A3016) Farnham

- (a) a raised table, the centreline of which will be a point 87 metres east of the centreline of its junction with (D5355) Sandy Hill Road;
- (b) a raised table, the centreline of which will be a point 33 metres south east of the centreline of its junction with (D5353) Spring Lane;
- (c) a raised table, the centreline of which will be a point 76 metres north west of the centreline of its junction with (D5353) Bishops Road;
- (d) a raised table, the centreline of which will be a point 15 metres south east of the centreline of its junction with (X68826) Wellesley Garden.
