## Notice The Surrey County Council Various Roads in Chipstead (20MPH Speed Limit) Order 202-

Surrey Council propose to make the above-named Order, under Section 84 of and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 (as amended) and of all other enabling powers, the effect of which will be to: - **1.** Impose a maximum speed limit of 20 miles per hour on the lengths of roads specified and described in the Schedule to this Notice. **2.** The "Reigate and Banstead Borough Council The Borough of Reigate and Banstead (Various Roads in Chipstead)(Restricted Roads and 40 Miles Per Hour Speed Limit)Order 1997" shall be amended so shall have effect as though those Parts to the First Schedule that restricts the maximum speed limit to 30MPH in the lengths of and/or part of the lengths of C136 High Road, C136 Coulsdon Lane, C137 Hazelwood Lane, D1079 Bouverie Road, D1079 Highwold, D1079 Lissoms Road, D1079 Hollymead Road, D1080 How Lane, D1080 Yew Tree Close, D1083 Walpole Avenue, D1083 Doghurst Lane, D1084 Starrock Lane, D1084 Vincents Close and D1151 Castle Road specified and described in the First Schedule to this Notice, shall be revoked.

The speed limit proposed by this Order shall not apply to vehicles used by special forces in accordance with the Road Traffic Exemptions (Special Forces) (Variation and Amendment) Regulations 2011. - c) The entire length of C136 Coulsdon Lane.
- d) That length of C137 Hazelwood Lane that extends from its junction with C136 High Road, to a point 3m north of the southern property boundary of "Fairfield".
- e) The entire length of D1079 Bouverie Road.
- f) The entire length of D1079 Highwold (that extends from its junction with D1079 Bouverie Road, to its junction with X25281 Highwold).
- g) The entire length of D1079 Lissoms Road.
- h) The entire length of D1079 Hollymead Road.
- i) That length of D1079 Hollymeoak Road from its junction with C136 Portnalls Road to the boundary between the Borough of Reigate and Banstead and the London Borough of Croydon.
- j) The entire length of D1080 How Lane.
- **k)** The entire length of D1080 Yew Tree Close.
- I) The entire length of D1083 Walpole Avenue.
- m) The entire length of D1083 Doghurst Lane.
- n) The entire length of D1084 Starrock Lane.
