The Surrey County Council
(Various Roads in Guildford)
(20Mph Speed Limit) Order 202-

Surrey County Council propose to make the above-named Order, under section 84 of the Road Traffic Regulation Act 1984 (as amended) and of all other enabling powers, the effect of which will be to impose a 20mph speed limit on the lengths of roads specified and described in the Schedule to this Notice.

The speed limit proposed by this Order shall not apply to vehicles used by special forces in accordance with the Road Traffic Exemptions (Special Forces) (Variation and Amendment) Regulations 2011

- (h) The entire length of Josephs Road (D4005) Guildford
- (i) The entire length of Springside Court (D4005) Guildford
- (j) The entire length of the publicly maintained highway comprised within Langley Close (D4005) Guildford
