The Surrey County Council Various Roads in Runnymede and Surrey Heath (40mph and 50mph Speed Limit) Order 202-

Surrey County Council propose to make the above-named Order, under section 84 of the Road Traffic Regulation Act 1984 (as amended) and of all other enabling powers, the effect of which will be to

- (a) impose a 40mph speed limit on the lengths of roads specified and described in the First Schedule to this Notice.
- (b) impose a 50mph speed limit on the lengths of roads specified and described in the Second Schedule to this Notice

The speed limit proposed by this Order shall not apply to vehicles used by special forces in accordance with the Road Traffic Exemptions (Special Forces) (Variation and Amendment) Regulations 2011

- (a) That length of Longcross Road (B386) Chertsey as extends from its junction at the roundabout with (D523) Burma Road, (B386) Chertsey Road and (C10) Chobham Lane to a point 100 metres west of its junction with (B386) Holloway Hill.
- (b) The entire length of the circulatory carriageway comprised within the roundabout situated at the junction of (B386) Longcross Road, (B386) Chertsey Road, (D523) Burma Road and (C10) Chobham Lane
- (c) That length of Kitsmead Lane (D3017) Longcross as extends from its western junction with (B386) Longcross Road (in the vicinity of the property presently known as "Cedar House") to a point 250m southeast of its junction with (C10) Trumps Green Road and (C10) Chobham Lane
- (d) That length of Kitsmead Lane (D3017) Longcross as extends from its eastern junction with (B386) Longcross Road (in the vicinity of the property presently known as "The Post House") to its junction with (D3017) Kitsmead Lane, in the vicinity of the property presently known as "Kitsmead House"
- (e) The entire length of Accommodation Road (D3045) Chertsey
- (f) That length of Stonehill Road (D3045) Ottershaw as extends from a point 100 metres southwest of its junction with (B386) Holloway Hill to the Boundary Line between the Borough of Runnymede and the Borough of Surrey Heath
- (g) That length of Chobham Lane (C10) Chertsey/Longcross as extends from its junction at the roundabout with (B386) Longcross Road, (B386) Chertsey Road, and (D523) Burma Road to its junction at the roundabout with the access to Longcross Studios
- (h) The entire length of the circulatory carriageway comprised within the Roundabout situated at the junction of the access to Longcross Studios and (C10) Chobham Lane

- (i) That length of Chobham lane (C10) Longcross as extends from its junction at the roundabout with the access to Longcross Studios north-westwards for a distance of 40 metres
- (j) That length of Chobham Lane (C10) Longcross as extends from its junction at the roundabout with the access to Longcross Studios north-eastwards for a distance of 75 metres
- (k) The entire length of Burma Road (B523) Chobham
- (I) That length of Staple Hill Road (C10) Chobham extending from a point 200 metres west of its junction with (B386) Longcross Road eastwards, and including the offslip road to Longcross Road, to its junction with (B386) Longcross Road
- (m) That length of the northern arm of Staple Hill Road (C10) Chobham between the main carriageway of (C10) Staple Hill Road and its junction with (B386) Longcross Road
