Surrey County Council Propose to make the above named Order, under Section 84 of and Part IV of Schedule 9 to, the Road Traffic Regulation Act 1984, the effect of which will be as follows (1) to impose a 20 mph speed limit on the entire lengths of the roads in Thames Ditton specified in the Schedule to this Notice; (2) The Surrey County Council (Various Roads in Thames Ditton) (20 mph Speed Limit) Order 2003, will be revoked and the lengths of roads included in the existing 20 mph zone therein (Specified in the Second Schedule to this Notice) will be included in the proposed Order and zone (3) the length of Giggs Hill Road proposed to be part of the existing 20 mph zone as specified in the Notice dated 13/12/24 will also be added to the proposed Order (responses are not invited for this). The speed limits proposed by this Order shall not apply to vehicles used by special forces in accordance with the Road Traffic Exemptions (Special Forces) (Variation and Amendment) Regulations 2011.

First Schedule (Extension to 20 mph zone): (1) Speer Road – from the junction with St Nicholas Road in a northernly direction to the junction with Summer Road. (2) Summer Road – from its junction with the A309 Hampton Court Way to its junction with Ferry Works and Burton Court; and the entire lengths of the following – (3) Warwick Road; (4) Warwick Gardens; (5) Aragon Avenue; (6) Queens Road; (7) Alexandra Road; (8) River Bank; (9) Riversdale Road.

Second Schedule (Existing 20 mph zone): Giggs Hill Road, from its northern junction with Portsmouth Road to a point 35m south of its junction with Watts Road; Watts Road; Mercer Close; Linden Close; Ditton Close; Station Road; Basing Way; Basing Close; Basing Field Road; Weston Green Road, from its junction with Longmead Road to its junction with Station Road; Home Farm Close; Cam Gardens; Ember Court Road from its junction with Thistledene to its junction with Station Road; Speer Road from its junction with St. Nicholas Road to its junction with Station Road; Old School Square; Summer Road from its junction with Ferry Works and Burton Court to its

junction with High Street; High Street; Ashley Road; St. Leonard's Road; Queen's Drive; King's Drive; Portsmouth Avenue; River Avenue.
