Amendments to Waiting and Loading Restrictions and On-Street Parking Places in the District of Tandridge

Surrey County Council propose to make "The Surrey County Council (Various Roads in Tandridge) (Amendment of Waiting Loading and Unloading Prohibition and On-Street Parking Places Orders) (Amendment No.1) Order 202-", pursuant to Sections 1, 2, 4, 14, 32, 35, 36 and 45 to 53 of and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984: The purpose and effect of which is to amend the following Orders: -

- (1) The Surrey County Council (Various Roads in Tandridge) (Revocation and Consolidation of Free On-Street Parking Places) Order 2024
- (2) The Surrey County Council (Various Roads in Tandridge) (Revocation and Consolidation of Free On-Street Loading Bays) Order 2024
- (3) The Surrey County Council (Various Roads in Tandridge) (Revocation and Consolidation of Free On-Street Parking Places) (Disabled Persons) Order 2024
- (4) The Surrey County Council (Various Roads in Tandridge) (Revocation and Consolidation of Waiting Loading and Unloading Prohibitions and Restrictions) Order 2024

So as to: -

- (1) prohibit waiting by vehicles in certain lengths of Limpsfield Road, Warlingham and The Green, Warlingham; Exemptions for loading on and unloading from vehicles, boarding and alighting from vehicles, using vehicles for works on or adjoining the lengths of roads referred to in the First Schedule, the maintenance of those roads and the services in them and for disabled persons' vehicles in accordance with the Blue Badge Scheme, will apply to the aforementioned restrictions;
- (2) (a) replace a certain length of the free on-street parking bay on Limpsfield Road, Warlingham with a disabled persons free on-street parking to operate at all times, limited to 3 hours, no return within 1 hour;
 - (b) provide that certain other vehicles may wait in any of the disabled persons' free on-street parking places described herein in certain circumstances e.g. to allow persons to board or alight (maximum 2 minutes) to load or unload (maximum 20 minutes), etc.
- (3) replace a certain length of the free on-street parking bay on Limpsfield Road, Warlingham with a time-limited on-street parking bay. Limited to Monday Saturday 8.30am-6pm, 1 hour with no return within 1 hour.
- (4) (a) replace the existing disabled persons free-on street parking place in certain lengths of The Green, Warlingham with a goods vehicles on-street loading bay for the purpose of

- collecting or delivering goods by goods vehicles, from any premises adjacent to or in the vicinity of the loading bay, operational from 6am-8.30am and 6pm-7pm
- (b) provide that certain other vehicles may wait in the free on-street loading bay, referred to above, in certain circumstances e.g. works vehicles (when necessary), emergency service vehicles, etc;
- (c) provide that in the case of the goods vehicle on-street loading bay described in part (4)(a), outside the hours of operation indicated, a certain length of the goods vehicle loading bay may be used a disabled persons' free on-street parking place, limited to 3 hours with no return within 1 hour. The remaining length of the goods vehicle loading bay specified in part (4)(a) may be used as a time limited free-street parking bay. Limited to 1 hour with no return within 1 hour.
- (5) (a) replace a certain length of the free on-street parking bay on the western arm of The Green, Warlingham with a goods vehicle loading bay for the purpose of collecting or delivering goods by goods vehicles, from any premises adjacent to or in the vicinity of the loading bay, operational from 6am-8.30am and 6pm-7pm
 - (b) provide that in the case of the goods vehicle on-street loading bay described in part (5)(a), outside the hours of operation indicated the goods vehicle on-street loading bay may be used as time limited on-street parking. Limited to, 1 hour with no return within 1 hour.
- (6) replace a certain length of the free on-street parking bay on the western arm of The Green, Warlingham with time limited on-street parking. Limited to Monday – Saturday 8.30am-6pm, 1 hour with no return within 1 hour.
- (7) replace the remaining lengths of free on-street parking in certain lengths of Limpsfield Road, Warlingham and The Green, Warlingham with time limited on-street Parking. Limited to Monday – Saturday 8.30am-6pm, 1 hour with no return within 1 hour.

Make certain drafting amendments to the following existing Orders which impose waiting, loading and unloading and parking prohibitions and restrictions in the District of Mole Valley, which will not affect the operation of those prohibitions and restrictions:-

- (1) The Surrey County Council (Various Roads in Tandridge) (Revocation and Consolidation of Electric Vehicle Parking Places) Order 2024
- (2) The Surrey County Council (Various Lay-Bys in Tandridge) (Revocation and Consolidation of Free On-Street Parking Places) Order 2024
- (3) The Surrey County Council (Various Roads in Tandridge) (Revocation and Consolidation of Prohibition of Waiting of Heavy Commercial Vehicles) Order 2024

- (4) The Surrey County Council (Various Roads in Tandridge) (Revocation and Consolidation of Prohibition of Stopping Outside Schools) Order 2024
- (5) The Surrey County Council (Various Roads in Tandridge) (Revocation and Consolidation of Residents' On-Street Parking Places) Order 2024

Where a restriction is proposed herein any existing restriction on the same length of road will be revoked, unless otherwise indicated.
