Proposed Traffic Calming and Parallel Crossings
Waterside Drive (D3801) Walton-On-Thames

Notice is hereby given that Surrey County Council, in exercise of their powers under Section 23 of the Road Traffic Regulation Act 1984 and Section 90(A) to (I) inclusive of the Highways Act 1980, and after consultation with the Chief Officer of Police in accordance with Section 23(2)(A) of the said Act of 1984, propose to introduce two Parallel Crossings (pedestrian/cyclist) on raised tables and one raised table on Waterside Drive (D3801), Walton-On-Thames. The locations of the raised tables are as follows: -

- (1) At the junction of Waterside Drive and Terrace Road 5m south-west of the existing crossing and extending 12m in length with 1.4m ramps (1:15 gradient). The flat-topped raised table will extend across the full width of the carriageway and rise to a height of 75 millimetres;
- (2) A distance of 90m north-west from the ramp of the table specified at (1) above and extending 12.4m in length with 1.1m ramps (1:20 gradient). The flat-topped raised table will extend across the full width of the carriageway and rise to a height of 75 millimetres;
- (3) A distance of 135m north-west of the table specified at (2) above and extending 12.4m in length with 1.4m ramps (1:15 gradient). The flat-topped raised table will extend across the full width of the carriageway and rise to a height of 75 millimetres.

The parallel crossings will be centred on the raised tables numbered (2) and (3) above.

This Notice supersedes the one relating to raised tables and crossings on the same road dated 1 July 2022.
