

**Surrey County Council**  
**Amendments to Waiting and Parking Restrictions**  
**In the Borough of Elmbridge**

On 25 March 2022 and 8 April 2022, Surrey County Council (“the Council”) proposed to make certain amendments to the Orders which impose the waiting, loading and parking restrictions in the Borough of Elmbridge (specified in the said Notices). The Council now proposes to make The Surrey County Council (Various Roads in Elmbridge) (Waiting Loading and Unloading Restriction and On-Street Parking Places Orders) (amendment No. 2) Order 202-, (as further amended) under Sections 1, 2, 4, 32, 35, 36, 45, 46, 49, 51, and 53 of and Part IV of Schedule 9 the Road Traffic and Regulation Act 1984 (“the Act”), so as to: -

- (a)** Prohibit the waiting by vehicles in certain lengths of Waterside Drive, Walton-on-Thames, (1); at any time; and (2) Monday-Friday 11am-Midday; and provide that the usual exemptions, for loading on and unloading from vehicles, boarding and alighting from vehicles, for works on or adjoining the said lengths of roads, the maintenance of those roads and the services in them and for disabled persons vehicles in accordance with the Blue Badge Scheme, would apply;
- (b)** Prohibit the stopping by vehicles, in certain lengths of Waterside Drive, Walton-On-Thames, Monday-Friday 8am-5pm, as indicated by school keep clear zig-zag markings on site. Exemptions shall apply for any person causing a vehicle to stop in order to avoid an accident, or if required to do so by law, anything done with the permission of a police constable in uniform or in accordance with any sign placed by Surrey Police in accordance with Section 66 or Section 67 of the Act, or for any vehicle displaying a valid waiver certificate issued by the Council;
- (c)** Where a new restriction is imposed in this Notice, any existing restriction on the same length of road will be revoked.
