Surrey County Council Amendments to Waiting and Loading Restrictions And On-Street Parking Places in the Borough of Woking

On 18 April 2023 Surrey County Council made "The Surrey County Council (Various Roads in Woking) (Amendment of Waiting, Loading and Unloading Prohibition and On-Street Parking Places Orders) (Amendment No.5) Order 2023", pursuant to Sections 1, 2, 4, 32, 35, 36 and 45 to 53 of and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 ("the Act"), which will come into force on 24 April 2023. The purpose and effect of which is to amend the following Orders: -

- (1) The Surrey County Council West Byfleet Controlled Parking Zone in the Borough of Woking (Revocation and Consolidation of Waiting Restrictions and On-Street Parking Places) Order 2019;
- (2) The Surrey County Council (Various Roads in Woking) (Consolidation of Loading bays and Revocation) Order 2019; and -
- (3) The Surrey County Council (Various Roads in Woking) Electric Vehicle Parking Places Order 2021 -

So as to: -

- (a) Prohibit waiting by vehicles at any time in in certain lengths of Madeira Road and Lavender Park Road, West Byfleet. Exemptions for loading on and unloading from vehicles, boarding and alighting from vehicles, using vehicles for works on or adjoining the lengths of the said roads, the maintenance of those roads and the services in them and for disabled persons' vehicles in accordance with the Blue Badge Scheme, will apply to the afore-mentioned restrictions;
- (b) Provide free on-street loading bays in certain lengths of Station Approach and Lavender Park Road, West Byfleet, operational at all times, subject to the usual exemptions e.g. emergency vehicles, using vehicles for works on or adjoining those lengths of roads;
- (c) Introduce such electric vehicle on-street parking places in certain lengths of the roads specified in the Schedule to this Notice, to be used at the times and on the days specified therein by electric vehicles or hybrid vehicles for the purpose of charging the said vehicle by use of the electric charging post installed in respect of that parking place; Certain other vehicles may wait in such parking places in certain circumstances e.g. to allow persons to board or alight (maximum 2 minutes) to load or unload (maximum 20 minutes), etc. but no exemption shall apply to blue badge holders; and
- (d) Make certain drafting amendments to the following existing Orders which impose waiting, loading and unloading and parking prohibitions and restrictions in the Borough of Woking, which will not affect the operation of those prohibitions and restrictions: -
- (4) The Surrey County Council Various Roads in the Borough of Woking (Residents' On-Street Parking Places) Order 2019;
- (5) The Surrey County Council (Various Roads in Woking) (Revocation and Consolidation of Waiting Loading and Unloading Prohibition and Restriction) Order 2019;

- (6) The Surrey County Council Woking Controlled Parking Zone (Revocation and Consolidation of Waiting Restrictions and On-Street Parking Places) Order 2019;
- (7) The Surrey County Council Brookwood Controlled Parking Zone in the Borough of Woking (Revocation and Consolidation of Waiting Restrictions and On-Street Parking Places) Order 2019;
- (8) The Surrey County Council (Various Roads in Woking) (Consolidation of Free Street Parking Places and Revocation) Order 2019;
- (9) The Surrey County Council (Various Roads in Woking) (Consolidation and Revocation of Free Street Parking Places) (Disabled Persons) Order 2019;
- (10) The Surrey County Council (Various Roads in the Borough of Woking) (Prohibition of Stopping Outside Schools) Order 2019;
- (11) The Surrey County Council (Borough of Woking) Free On-Street Parking Places (Police Vehicles) Order 2019;
- (12) The Surrey County Council (Borough of Woking) (Bus Parking Places and Revocation) Order 2019;
- (13) The Surrey County Council Various Roads in the Borough of Woking (On-Street Car Club Parking Places) Order 2019.

Where a restriction is proposed herein any existing restriction on the same length of road will be revoked, unless otherwise indicated

If you wish to question the validity of the Order or of any provision contained in it on the grounds that it is not within the powers conferred by the Act, or on the grounds that any requirement of the Act or of any Instrument made under it has not been complied with in relation to the Order, you may, within six weeks from the date of the making of the Order, apply to the High Court for this purpose.

Any reference to a road in the Schedules is a reference to part of the road only, see plans on the website for details.
