Proposed Traffic Calming Measures
in Whyteleafe Road (C227) Caterham

Notice is hereby given that Surrey County Council in exercise of their powers under Section 90(A) to (I) inclusive of the Highways Act 1980 propose to introduce a series of physical measures to improve safety and reduce vehicle speeds in Whyteleafe Road (C227) Caterham. These measures will include: -

- (a) a flat top road table which will extend from a point 130.3 metres north of its junction with Cedar Park northwards for a distance of 9.75 metres. The road table will extend across the full width of the carriageway, will measure 75 millimetres in height, 7.5 metres in length and will have 1.125 metre ramps at a gradient of 1:15
- (b) three pairs of speed cushions, the locations of which are specified and described in the Schedule to this Notice and one cushion of each pair will be located centrally in each of the northbound and southbound carriageways. The proposed speed cushions will be flat topped and will measure 75 millimetres in height, 3.7 metres in overall length and 1.6 metres wide with 0.8 metre main ramps at a gradient of 1:10.

Whyteleafe Road (C227) Caterham

- (a) a pair of speed cushions extending from a point 16 metres north of its junction with Cedar Park for a distance of 3.7 metres (including both ramps) northwards
- (b) a pair of speed cushions extending from a point 58.7 metres north of its junction with Cedar Park for a distance of 3.7 metres (including both ramps) northwards
- (c) a pair of speed cushions extending from a point 102.3 metres north of its junction with Cedar Park for a distance of 3.7 metres (including both ramps) northwards
