## Surrey County Council - Borough Of Guildford

Proposed New Traffic Regulation Order Regarding Changes To The Two Existing Bus Lanes In Woking Road (A320), Guildford In Connection With The Implementation Of The Guildford Town Centre Transport Package And Guildford Quality Bus Corridor

1. SURREY COUNTY COUNCIL PROPOSE TO MAKE The Surrey County Council (Woking Road (A320) Guildford) (Amendment of Bus Lanes) (No. 1) Order 202- under Sections 1(1), 2(1) to (3) and 4(1) of and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 ("the 1984 Act") and of all other enabling powers; the purpose and effect of which would be to provide that, in respect of the two existing mandatory "with-flow" bus lanes situated in Woking Road (A320) Guildford:

- (a) to increase the hours of operation of both of the aforesaid bus lanes so that they would be in operation at any time of the day of night throughout the week; and
- (b) carry out certain drafting amendments to the existing Traffic Regulation Order currently enforcing the aforesaid two bus lanes which will not affect the operation of both of those bus lanes, except as provided for in sub-paragraph (a) above.

2. A copy of the proposed Order, together with a Plan showing the lengths of Woking Road (A320) Guildford to which that Order relates, The County Council of Surrey Woking Road (A320) Guildford (Bus Lanes) (No. 1) Order 2002, the Statement of the County Council's reasons for proposing to make the Order and a Statement of the County Council's Guidelines for the Acceptance of Objections to Traffic Regulation Orders may be inspected, free of charge, at:
