

**Notice**  
**Surrey County Council**  
**Imposition of 20mph Speed Limit in D3708 White Rose Lane D3714 Bylands**  
**and D3708 Rosewood, Woking**

1. Surrey County Council ("County Council") propose to make "Surrey County Council (Various Roads in Woking) (20mph Speed Limit) Order 202-", under Section 84 of the Road Traffic Regulation Act 1984 "the Act" (as amended) and all other enabling powers, the effect of which will be to impose a 20mph speed limit in the lengths of roads specified in the **Schedule** to this Notice.
2. The 20mph speed limit imposed by this Order shall not apply to vehicles used by special forces in accordance with the Road Traffic Exemptions (Special Forces) (Variation and Amendment) Regulations 2011.
3. A copy of the proposed Order, a plan showing the lengths of roads to which the Order relates, a Statement of the Council's reasons for proposing to make the Order and a Statement of the Council's guidelines on the acceptance of objections to Traffic Regulation Orders may be viewed on-line at <https://www.surreycc.gov.uk/roads-and-transport/policies-plans-consultations/roads-and-transport-consultations> (follow the link to **White Rose Lane, Bylands and Rosewood, Woking 20mph speed limit and traffic calming proposals**).   - (b) Woking Borough Council, Civic Offices, Gloucester Square, Woking, Surrey, GU21 6YL (pre-booked appointments Monday to Friday 9am to 1pm);
  - (c) Woking Library, Gloucester Walk, Woking, Surrey, GU21 6EP, 9.30am to 5.30pm (Monday, Wednesday and Friday), 9.30am to 7pm (Tuesday and Thursday) and 9.30am to 5pm (Saturday).
4. If you wish to object to, or make any other representation regarding the proposed measures, you must send the grounds for your objection or representations (including any in support) by **10 July 2025** –
  - (a) in writing to Traffic Regulation Orders Team, Surrey County Council, Hazel House, Merrow Lane, Guildford, Surrey, GU4 7BQ;
  - (b) or by using the online form via the website quoted above.

**(20mph Speed Limit)**

1. D3708 White Rose Lane, Woking – from a point 25m south of its junction with Heathside Road to its junction with Old Woking Road;
2. D3714 Bylands, Woking – its entire length;
3. D3708 Rosewood, Woking – its entire length.
