

**Surrey County Council**  
**Proposed Traffic Calming Measures**  
**in D3709 Heathside Road, Woking and D3708 White Rose Lane, Woking**

SURREY COUNTY COUNCIL in exercise of their power under Section 90(A) to (I) inclusive of the Highways Act 1980 propose to introduce a series of traffic calming features in D3709 Heathside Road, Woking and D3708 White Rose Lane, Woking, as follows. The proposed raised tables and road tables will have a height of 75mm with main ramps at 1.2m at a gradient of 1:15. Each of the proposed speed cushions will have a height of 75mm and 2m in length, with main ramps 0.6m in length at a gradient of 1:8 and side ramps 0.3m in length at a gradient of 1:4.

1. D3709 Heathside Road, Woking and D3708 White Rose Lane, Woking
  - (a) **full width flat-topped raised junction table**, extending 25m west and 13.9m east (onto Heathside Road) of the centre of the junction of Heathside Road and White Rose Lane, Woking and extending 13.1m north and 10.3m south (onto White Rose Lane) of the centre of the junction of Heathside Road and White Rose Lane, Woking. Note – the existing zebra crossing on Heathside Road will be raised and reinstated on top of the table.
2. D3708 White Rose Lane, Woking
  - (a) **tapered edge road table**, centred at a point 2.2m east of lamp column N30, 3.95m in wide and 4m in length, with side ramps at 0.3m at a gradient of 1:3;
  - (b) **tapered edge road table**, centred at a point in-line with lamp column N34, 4.25m wide and 4m in length, with side ramps at 0.3m at a gradient of 1:3;
  - (c) **tapered edge road table**, centred at a point 22m east of lamp column N45, 4.55m wide and 4m in length, with side ramps at 0.3m at a gradient of 1:3;
  - (d) **tapered edge road table**, centred at a point 31.5m of its junction with Knoll Hill, 4.65m wide and 4m in length, with side ramps at 0.3m at a gradient of 1:3;
  - (e) **two abreast speed cushions**, centred at a point 40m north of its junction with Heathside Park Road, 1.8m in width;
  - (f) **two abreast speed cushions**, centred at a point 33m north of its junction with Hill View Road, 1.85m in width;
  - (g) **two abreast speed cushions**, centred at a point in-line with the property boundary line of No.37 and No.39, 1.7m in width;
  - (h) **two abreast speed cushions**, centred at a point 14.5m south-east of the access to the property known as “Toad Hall”, 1.9m in width;

- (i) **two abreast speed cushions**, centred at a point 12m east of the western junction with Cleardown, 1.6m in width.
