The Surrey County Council Woodhatch Road (A2044) Reigate/Redhill (30 Mph and 40 Mph Speed Limit) Order 202-

Surrey County Council propose to make the above-named Order, under section 84 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 (as amended) and of all other enabling powers, the effect of which will be to

- (a) extend the 30 miles per hour maximum speed limit in that length of Woodhatch Road (A2044) Reigate as extends from a point in line with Street Lighting Column N30 to a point 388 metres east of its junction with (D1295) Tiler's Way. NB Woodhatch Road (A2044) Reigate as extends from its junction with (A217) Dovers Green Road/Cockshot Hill to a point in line with Street Lighting Column N30 will have a 30 miles per hour maximum speed limit by the system of streetlighting that is already in place.
- (b) impose a 40 miles per hour maximum speed limit in that length of Woodhatch Road (A2044) Reigate/Redhill as extends from a point 388 metres east of its junction with (D1295) Tiler's Way to its junction with (A23) Horley Road.
- (c) Revoke the "Reigate and Banstead Borough Council The Borough of Reigate and Banstead (Woodhatch Road (A2044) Reigate/Redhill) (Restricted Road and 40 mph Speed Limit) Order 2000" in its entirety.

The speed limits proposed by the above-mentioned Order shall not apply to vehicles used by special forces in accordance with the Road Traffic Exemptions (Special Forces) (Variation and Amendment) Regulations 2011.
